Scope and Content Note:

This collection consists of deeds, mortgages, and estate papers related to the Lansing and Bleecker families of Albany, New York. Included are fourteen deeds and mortgages between a number of different individuals and members of the Bleecker and Lansing families. Lands involved include lots and parcels in Albany, Greene, Chenango, Oneida, Otsego, and Broome counties. Also included are papers relating to the settlement of the estate of Isaac Truax. These items were collected by Bleecker Lyon.
